

Ed Kelly Education Award – Three to be Presented

The Edward S. Kelly Education Award will be presented at the 2010 ACA Convention Banquet on Friday, April 16, 2010. Three cash awards of \$250 will be presented to the three students attaining the highest scores in completing the Associate-in-claim (AIC), CPCU, and Senior Claims Law Associate (SCLA) designation in 2009. The three individuals will also be presented with plaques commemorating their achievements.

Only current ACA members are eligible to receive these awards. Scores cannot be obtained unless INS, AIC, SCLA, or CPCU courses have been completed during the 2009 calendar year.
